the fourth-degree felony of possession or transfer of a large-capacity magazine, meaning one with a 10-round or greater capacity (down from 15 rounds in last year's HB156). Provides exceptions and definitions. Appropriates \$1.5 million (GF) to the Department of Public Safety for FY 2024, which includes funding of additional local and statewide law

Comments: Meeting of 24 Jan 23: DPS noted that the definition of "large

capacity magazine" is really the standard magazine for most firearms these days, as 10 rounds is the standard magazine capacity; the bill is likely untenable under the 2nd Amendment; last year the ban was 15-round capacity, and now it is down to 10. DPS added than many bills are putting the onus of

distributing funds on DPS, when that is really a DFA function;

DPS does not have the manpower to distribute funds.

Additionally, DPS added that it is unclear what the appropriation attached to this bill is intended to accomplish or support, and that the re-sale mechanism in some bills is not functional as firearms dealers do not have the capacity to sell the stock they have, or cannot use the weapons that people bring to them for sale. AODA noted that it would be a problem to enforce this bill as almost every handgun has that capacity. The committee voted

not to support this legislation, due to the concerns expressed by DPS, by a vote of 10-0.

AGO noted that they agreed with the DPS and AODA comments, adding that grand juries were useful to launch cases, and that there is already proper oversight of grand juries as defense attorneys can challenge grand jury findings; they added that if use of grand juries is eliminated, vulnerable victims would have to be brought in three times - for the pre-trial interview, for the preliminary hearing, and for the trial, which would add to the

stress on these victims. DPS added that there would also be an impact on law enforcement officers who would need to spend more time in court than they already do. AOC noted that although retired Justices and Judges are in support of this bill, the present Court has not taken a position on this bill. LOPD noted that the comments indicate why the defense bars have concerns with the use of grand juries, that if they were rarely used there would not be an issue, but they are generally used to quickly bring a charge, effectively becoming a processing tool.
