**Tell your story.** Justice Counts helps agencies showcase their work and can help agency leaders better advocate for the resources they need.



**Save time and resources.** Rather than running the same report for every stakeholder that asks, Justice Counts data are available at the ready and reduces strain on staff.



**Measure impacts.** Justice Counts can help agencies measure how policy changes at their agency impact their trends compared to a control group of other participants.



**See full-system impact.** Justice Counts creates a system-wide view that connects steps in the justice system process that are often siloed.



**Learn from other agencies.** Justice Counts can connect similar agencies and systems nationwide, creating peer learning opportunities and collaborations on strategy.

## What data do agencies share?

Justice Counts invites agencies to leverage aggregate data they already collect to populate consensus-based metrics. Aggregate data means that no data share agreement is necessary to participate in Justice Counts and that with little or no additional data manipulation, agencies can start sharing data through Justice Counts today.


Justice Counts provides a tool called *Publisher* for agencies. *Publisher* helps agencies identify which metrics they will share data for, define in granular detail what their data means, and then easily publish data.

Data already shared to aggregating efforts (such as NIBRS) can easily be incorporated to avoid duplications of effort by agency staff.

#### What happens once agencies share data?


Once shared, agency data will be automatically published to public dashboards. These dashboards will present visualizations of

trends and snapshots, and while they may provide analysis of those trends, they will not include specific policy recommendations.
