Crime Reduction Grants Awarded for FY2025, Round 1

Coordination of Law Enforcement & Treatment

13th JD: Valencia Medicated Assisted Treatment (VMAT)

Provides funding to address shortfalls in key processes in the continuity of care of inmates being released into the community, including hiring a case manager, implementing strategies to recruit and retain staff, and expanding software to ensure the sharing of information after discharge to treatment providers.

Crisis Intervention Team

6th JD: Hidalgo County Community Response Team

Provides funding to assist local teams in development and execution of pilot projects aimed at improving the court and community response to those with mental illness and substance misuse intervention needs.

Evidence-Based Prevention, Treatment & Supervision

2nd JD: Bernalillo County Warrant Forgiveness Walk-In Program

Provides funding to address the significant number of outstanding warrants. Defendants are frequently afraid to re-engage with the criminal justice system to address an outstanding warrant due to the fear of arrest.

13th JD: Resource Assessment Center Program

Provides funding for a Resource Assessment Center for those 18 and older who have had police contact or are considered at-risk of police contact. The Center is focused on decreasing contact with law enforcement by assessing clients' needs and strengths and providing case management services.

Pre-Prosecution Diversion

2nd JD: Pre-Prosecution Diversion Program

Provides funding for removing low level offenders from the criminal justice system and placing them into treatment and rehabilitation services through the DA's Pre-Prosecution Diversion (PPD) program or Specialty Courts.

8th JD: Taos LEAD

Provides funding for Law Enforcement Assisted Diversion (LEAD). Law enforcement identify and refer people with substance use disorder (SUD) to the program, which helps reduce criminal behavior, decrease usage of emergency services, improve public safety, reduce drug overdoses and occurrence of SUD, and improve the quality of life of people dealing with SUD.

Pretrial Service Program

1st JD: Pretrial Peer Support

Provides funding to hire a certified peer support worker to assist individuals charged with a criminal offense in the district court in complying with conditions of release.

4th JD: Pretrial Justice and Community Engagement

Provides funding to address pretrial services in the following ways: (1) GPS services, (2) purchase of clothing and equipment for defendants, and (3) community engagement.

Re-Entry

2nd JD: Re-Entry Center Liaison LOPD Staffing

Provides funding to staff a Resource Re-Entry Center as a first stop for individuals who are released from custody where they have access to case management, transition plans, and transportation.

11th JD: San Juan County Re-Entry Support

Provides funding to assist individuals being released back into the community with transportation, housing, substance use treatment, and provide access to healthcare, mental healthcare, and recovery support services.

Specialty Court

2nd JD: Lease of Remote Alcohol Monitoring Devices

Provides funding for the Bernalillo County Metropolitan Court to lease Remote Alcohol Monitoring Devices (SCRAM/CAM) and use a Transdermal 24/7 alcohol monitoring agency for these devices.

5th JD: Chavez Adult Treatment Court Program FY25

Provides funding for the Chaves County Adult Treatment Court Program to offer incentives to participants to increase engagement with program requirements and in turn improve outcomes within their individual and social environments.

10th JD: Adult Treatment Court for the Tenth Judicial District Court

Provides funding to establish a treatment court program in Quay County with the assistance of contracted service providers. The funding is used to hire a treatment court coordinator as well as for team members to attend conferences and trainings.
