Summary: (Executive Message 72) House Bill 9, known as the “Immigrant Safety Act,” prohibits New Mexico public bodies from participating in the federal civil immigration detention system. The law bans the use of public resources or property to hold individuals for federal immigration violations and mandates the cancellation of all current detention contracts.

Title: JUVENILE FIREARM USE AND BACKGROUND CHECKS
Summary: (Governor's Message 7) House Bill 25 amends three sections of law in the Criminal Code to tighten firearm violations by an adult with a previous record involving firearms as a juvenile that would have been a felony if committed by an adult. Authorizes the court record of a juvenile disposition involving the use of a firearm to become part of the FBI's criminal background records for a period of ten years following the disposition as a juvenile. Makes it unlawful for an adult subject to a juvenile disposition for a delinquent act involving a firearm to receive, transport or possess a firearm.

Comments: Meeting of 27 Jan 26: A public member noted that CYFD's legal division was working with the Governor's office on this bill; there are concerns about the felony part for children, which will be cleaned up. LOPD noted that there is a provision in the Delinquency Act that conflicts with this bill. Upon a motion by a public member, seconded by NMCD, the committee voted to support this legislation (7 to support – Chair, AOC, AODA, DPS, NMCD, and two public members; 3 against – LOPD and two public members; 2 abstentions – District Court Judge and Magistrate Judge).

Title: CRIMINAL & CIVIL TORT ACTIONS: SENSITIVE DEEPFAKE IMAGES
Summary: House Bill 22 relates to invasion of privacy and provides for both criminal penalties and civil remedies for either distributing or threatening to distribute sensitive deepfake images (digitally created or manipulated depictions of a person in nude or sexual contexts) with the intent to harass, intimidate or humiliate another or cause them to suffer unwanted physical contact or substantial emotional distress. The bill primarily affects individuals who create, distribute, or threaten to distribute such

Summary: House Bill 39 outlaws selling or attempting to sell a ticket to an event hosted by the state, a political subdivision of the state (county, municipality) or a nonprofit entity at a price greater than what is charged at the event or printed on the ticket, a practice called scalping.

Title: CREATES CRIME OF DIGITAL SABOTAGE OF A BUSINESS
Summary: Amends the Computer Crimes Act to create the crime of digital sabotage of a business, defined as using a business’s digital resource to provide false or misleading information, damage the functioning of a digital resource or the business, or redirect a potential customer searching for the business to a different network location. Penalties range from a second degree felony down to a petty misdemeanor, depending on the amount of damages.

Title: PENALTIES FOR FELON IN POSSESSION OF FIREARM
Summary: (Governor’s Message 2) (Similar to 2025 HB496) House Bill 49 amends New Mexico’s statutes regarding the unlawful possession, transportation, or receipt of firearms or destructive devices by a convicted felon. The bill replaces current penalties—which vary based on the nature of the prior conviction—with increased first- and second-degree felony classifications.

Comments: Meeting of 27 Jan 26: DPS noted that this is one of the Governor’s bills, that it was important to have severe penalties on people who violate this statute, and even if there is not much of a deterrent effect it is important that there are consequences. A public member noted that these sanctions have no deterrent effect. District Judge noted the importance of data to these discussions. LOPD noted the NMSC’s data on the effectiveness of the increased penalties over the last many years shows that there has been little to no effect; LOPD also noted that these penalties are quite severe for a crime that does not necessarily involve the use of a weapon and thinks that the current penalty is appropriate. Upon a motion by DPS, seconded by NMCD, the committee voted to support this legislation (6 to support – Chair, AODA, DPS, NMCD, and two public members; 3 against – LOPD and two public members; 4 abstentions – AOC, District Court Judge, Magistrate Judge, and a public member).

Summary: (House Executive Message 33) House Bill 52 is a technical statutory reconciliation bill that updates cross-references to Sec. 33-2-34 of the Criminal Code. The bill makes no substantive changes to existing law and mainly updates references to such terms as “serious violent offense” and “felon” to match the current numbering in Sec. 33-2-34, as amended in 2025.

Comments: Meeting of 27 Jan 26: NMCD moved to support this bill as the cleanup was because of the EMD bill. Upon a motion by NMCD, seconded by a public member, the committee voted unanimously to support this legislation.

Title: CHEMICAL ANALYST TESTIMONY BY VIDEO FOR TRAFFIC OFFENSES
Summary: (House Executive Message 34) Nearly identical to 2025 HB105; 2024 HB62; 2023 HB159) Adds a new section to the Implied Consent Act to permit an analyst or toxicologist to testify at a court proceeding related to traffic offenses via interactive video. A defendant is deemed to have given consent to an analyst’s interactive video appearance if the analyst is subpoenaed to testify about chemical testing that the analyst performed to determine if the defendant was driving a motor vehicle under the influence of intoxicating liquor or drug.

Comments: Meeting of 27 Jan 26: AODA noted that in rural districts, getting in person testimony from these experts is difficult; video testimony in cases is often allowed if the victim consents; video testimony avoids travel; make sense to be part of the Implied Consent Act. LOPD noted that the Confrontation Clause issues were front and center of their analysis; given the posture of current case law, they cannot support this bill. Magistrate Judge noted that in their courtroom experience, if the expert is present, that often results in a plea, but if not, there is usually a motion to suppress. A public member noted the importance of a witness to appear in person, as confrontation over video is not the same. Upon a motion by AODA, seconded by DPS, a motion to support this legislation failed (4 to support – Chair, AODA, DPS, NMCD, and a public member; 5 against – LOPD and four public members; 4 abstentions – Chair, AOC, District Court Judge, Magistrate Judge).

Summary: (Governor's Message 19) Amends the Criminal Code to increase the basic sentence for a second degree felony resulting in the death of a human being from 18 to 25 years imprisonment. The current maximum fine for the same crime remains at \$12,500.

Comments: Meeting of 27 Jan 26: DPS noted that this is one of the Governor's bills, and that it was necessary to have serious consequences for a crime this serious. LOPD noted that the penalty for this crime had been increased recently, in 2024. AODA noted that they have seen several situations where a first degree murder charge could have been pled to second, but the gap in penalties was too large, which affects the prosecution's ability to negotiate a plea deal. A public member suggested that perhaps it was time to amend the first degree murder statute. Upon a motion by DPS, seconded by AODA, the committee voted to support this legislation (6 to support – Chair, AODA, DPS, NMCD, and two public members; 3 against – LOPD and two public members; 4 abstentions – AOC, District Court Judge, Magistrate Judge, and a public member).

Comments: Meeting of 27 Jan 26: DPS noted that this is one of the Governor's bills; he related anecdotes about officers he has known in his 27 years in uniform who were definitely in the category of victims, and the times they received notifications like those required in the Victims of Crimes Act and how important that was to them. LOPD asked about whether the restitution provisions would apply to officers. Upon a motion by DPS, seconded by NMCD, the committee voted to support this legislation (10 to support – Chair, AODA, DPS, NMCD, Magistrate Judge, and five public members; 0 against; 3 abstentions – AOC, LOPD, and District Court Judge).

Summary: (Governor's Message 6) (Identical to 2025 HB103; 2024 HB61) Proposes to make the crime of committing aggravated battery on a police officer a second degree felony when 1) inflicting great bodily harm; 2) doing so with a deadly weapon; or 3) doing so in any manner whereby great bodily harm or death can be inflicted.

Comments: Meeting of 27 Jan 26: DPS noted that this is one of the Governor's bills, and that he had seen an increase in aggravated battery cases against law enforcement; they mentioned a recent incident where an officer was shot from a random direction while conducting a traffic stop; there is a need to protect officers. LOPD noted that while there might be an increase, there is no data to support that increasing the penalty will decrease the incidence of the crime; there were problems overall with separating various aggravating battery crimes by profession; LOPD also noted that there was a big jump in penalty from three years to nine, and that there was a risk of overcharging. AODA disagreed and noted that police officers were one case where there were strong reasons for there being a greater penalty. A public member noted that they would support the bill if they thought that it would actually protect officers. Upon a motion by DPS, seconded by NMCD, the committee voted to support this legislation (6 to support – Chair, AODA, DPS, NMCD, and two public members; 3 against – LOPD and two public members; 4 abstentions – AOC, District Court Judge, Magistrate Judge, and a public member).

Summary: Amends the Family Violence Protection Act to require a restrained party to relinquish any firearm while an order of protection is in effect; no longer requires a showing of credible threat.

Title: CRIMINAL PENALTY: DISTRIBUTION OF CONTROLLED SUBSTANCE TO MINOR

Summary: (House Executive Message 29) House Bill 72 amends Chapter 30 of New Mexico’s controlled substances laws relating to the penalty for adults who intentionally distribute certain controlled substances to minors by increasing the penalty to a first-degree felony level for distribution that involves Schedule I or II narcotic drugs and methamphetamine (and their analogs). (Under existing law, the basic sentence is 18 years imprisonment and a fine of up to \$15,000.)

Title: LIMITS COURT'S AUTHORITY TO SUSPEND OR DEFER SENTENCES

Summary: (House Executive Message 30) House Bill 73 amends the Sentencing law to limit the level of a basic sentence that the court may defer or suspend when imposing a sentence for a second- or third-degree felony offense on a defendant who was previously convicted of a felony offense. In such cases, the court’s authority to defer or suspend is limited to no more than two-thirds of the basic sentence. Despite the two-thirds limit, the court may “otherwise alter the basic sentence” based on mitigating or aggravating circumstances as allowed by existing law.

Comments: Meeting of 27 Jan 26: A public member noted that the habitual offender statute is likely unconstitutional, as it shifts discretion away from the courts; the ten-year restriction was part of the compromise behind the passage of the legislation; they added that the NMSC has historically opposed legislation that undermines judicial discretion. LOPD noted that the reason for the ten-year restriction is that people should have to face accountability for what they have done now, not a long time ago; the Supreme Court noted that the policy justification was to differentiate the incorrigible defenders from people who could rehabilitate; they also noted that there is a pending Supreme Court case on elements of this statute. DPS noted that if someone has managed to turn their life around after ten years, they could get consideration. A public member noted that most felonies are non-violent. Upon a motion by a public member, seconded by another public member, the committee voted not to support this legislation (7 not to support – Chair, LOPD, and five public members; none against; 6 abstentions – AOC, AODA, DPS, NMCD, District Court Judge, Magistrate Judge).

Comments: Meeting of 3 Feb 26: NMCD noted that the version of this bill that was considered last year removed some of the appointment power of the Executive; that has been put back this year; the Parole Board does a lot of work, for which they are not adequately compensated; this makes it difficult to hold and retain members, and when the membership numbers on the Parole Board drop, that increases the work for the remaining members significantly. A public member noted that they used to be on the Parole Board, and that the materials took a few days to read through, but the compensation was only per diem for the day of the meeting. LOPD noted that they were impressed with the work of the Parole Board and support increasing their compensation. A public member noted that it was good to put these considerations into statute, that under the present model the first Parole Board meeting tends to be static, and the second one is the true opportunity to have a proper hearing as the person before the Parole Board knows better what will be required, which could help increase the chances of someone being found eligible for parole. AODA noted that they were concerned about the impact on victims, and that the language in the bill seems to encourage the Parole Board to release people, which prevents them from supporting the bill. Upon a motion by NMCD, seconded by a public member, the committee voted to support this legislation (10 to support – Chair, DPS, LOPD, NMCD, Magistrate Judge, and five public members; 1 against – AODA; 1 abstention – District Court Judge).

DPS noted that they sit on the Organized Crime Commission and have seen the problems that drones are causing, particularly with potential risks to security and critical infrastructure; the range and capabilities of drones present an extraordinary challenge to national security. Chair noted that they know of two instances where drones were used to track Native Americans to sacred grounds so that they could be discovered and accessed by outsiders. A public member said that while the discussion was important, they could not support the creation of a new crime; a regulatory approach might be better rather than creating a separate crime for this behavior; there are other statutes, such as prohibitions on contraband in prisons, trespass, or voyeurism, that could cover this behavior; if the goal is to have authority over the airspace, then civil law is all that is needed. A public member agreed that we need to look to existing law rather than create a new crime, and that creating a new crime will not achieve anything; they suggested that NMCD look at these types of laws that are already on the books. Upon a motion by NMCD, seconded by DPS, the committee voted to support this legislation (7 to support – Chair, AODA, DPS, NMCD, and three public members; 1 against – a public member; 4 abstentions – LOPD, District Court Judge, Magistrate Judge, and a public member).

A member of the public attending the meeting noted, in terms of the severity of the present statute, that they had a client who was 18 and due to the enhancements in this statute ended up with 18 years in prison for their first felony offense; and that it would be interesting to see whether the data on the use of this statute supports whether there is an impact on public safety. There was some discussion of how the statute adds mandatory time to the person's sentence, but is not mandatory for prison time. A motion to support this legislation was made by DPS, seconded by NMCD, failed (3 to support – AODA, DPS, and NMCD; 5 against – LOPD, and four public members; 4 abstentions – Chair, District Court Judge, Magistrate Judge, and a public member).

Another public member noted that there were concerns at CYFD about holding offenders until they were 25, which would necessitate \$12 million to bring an additional facility on line, and that the bill carries no appropriation; that the bill incorporates supervised release from HB 434 from the last Session; and that it includes changes to the Juvenile Community Corrections Act similar to SB 147, the NMSC bill, but keeps the panels. NMCD noted that there were discussion to modify that age range. A member of the public attending the meeting noted that the Council of State Governments did a deep dive into the juvenile justice system in New Mexico, but none of their recommendations were included in this bill.
